

# For authors of publications in “Asthma and Allergy” journal: rules for articles preparation

“Asthma and Allergy” journal is a peer-reviewed scientific and practical edition certified by the Higher Attestation Commission (Resolution of the HAC presidium No 105/6 from 12.06.2002) and included in the List of scientific professional editions of Ukraine (Order of the Ministry of Health of Ukraine No 455 from 15.04.2014). The Journal is included in the category "B" of the list of scientific professional editions of Ukraine ([Order of the Ministry of Education and Science of Ukraine](#) № 886 from 02.07.2020). [Media identifier R30-05313](#) according to the decision of the National Council of Television and Radio Broadcasting of Ukraine dated 13.06.2024 No. 2043.

Users have a possibility free and at no cost to read, download, copy and distribute content with educational and research purpose with obligatory mentioning of the authorship.

If the site is temporarily unavailable or the journal is discontinued, electronic copies of the journal issues are available on the sites of [Vernadsky National Library of Ukraine](#), [Google Scholar](#), [Index Copernicus](#), [WorldCat](#) and others.

This license allows others to distribute, edit, make changes, and take your work as a basis for their works, even for commercial use, provided that the authorship and reference to the journal citation are indicated [“Asthma and Allergy” journal](#). When referring to an article in our journal, the journal name should be given in Ukrainian – «Астма та алергія» or English – «Asthma and allergy».

**Publication of materials in the journal is free of charge for authors.**

## Policy (purpose and objectives) of the journal

"Asthma and Allergy" journal is a specialized scientific and practical journal, which one of the most famous specialized publications on this topic in Ukraine. The journal publishes scientific articles on respiratory medicine and allergology. The purpose of the publication: to inform pulmonologists, allergologists, immunologists, general practitioners and pediatricians about the latest achievements in the diagnosis, treatment, prevention of allergic diseases, bronchial asthma, COPD, their combination with the sleep obstructive apnea hypopnea syndrome. The journal publishes reviews of leading Ukrainian scientists and opinion leaders from other countries in the field of allergy diagnostics, differential diagnosis, pharmacological therapy of allergic diseases, including pregnancy, and specific allergen immunotherapy (SIT). In addition, the journal publishes useful information on allergy and pulmonology issues from Ukrainian and international congresses (ERS, EAACI, Asthma-Congress, etc.). At conferences and seminars the latest clinical national and foreign guidelines on current topics (recommendations of Ukrainian, European and American respiratory communities, WHO), as well as research with new medicines of Ukrainian and foreign companies are placed.

## **Review policy**

- Articles in "Asthma and Allergy" have been systematically reviewed since 2002.
- Newly submitted articles are initially evaluated by the editorial staff for completeness, content and compliance with the "Requirements to Authors".
- The editorial board evaluates the results of the initial evaluation, and submits the article to two reviewers - independent experts whose specialization is closest to the subject of the article.
- Peer review type: a double-blind review, which means that the reviewer and author remain anonymous during the review process.
- By default, the review period is two weeks, however, this period can be extended depending on the situation and at the request of the reviewer.
- The editor provides the authors with reviews without revealing the names of the reviewers.
- The reviewer can give the following conclusions on the author's article:
  - suitable for copyrighted printing;
  - suitable for printing with corrections for these remarks (without further re-examination);
  - recommended for additional testing by another reviewer;
  - not printable.
- The editor in chief reviews the opinions of the reviewers and approves or disapproves the article for print.
- If the author disagrees with the review, he or she may submit a reasoned response to the editor. The editorial board decides on the suitability of the publication based on the validity of the article and its relevance to the subject area of the journal. In conflict situations, the editor-in-chief makes the decision.
- Each issue of the journal is approved at a meeting of the Academic Council of the State organization "National Scientific Center of Phthisiatry, Pulmonology and Allergology named after F. G. Yanovski National academy of medical sciences of Ukraine" (founding organization).

- The decision to publish the author's article is made on the basis of scientific expertise. It is the responsibility of the reviewer to provide a fair and impartial conclusion as to the expediency of publishing or rejecting the work.

- In the performance of his / her duties, the reviewer is guided by the following ethical principles: the manuscript submitted for review has a confidential status and is not passed on to third parties without proper authority; the data contained in the author's manuscript cannot be used by the reviewer for personal or other purposes; the reviewer does not personally criticize the author.

## **Editorial ethics**

### **Editor in chief**

Editor-in-chief organizes the work of the editorial board, reviewers and makes the final decision to publish the author's research.

The decision is based on the adherence to the article's scientific criteria, the relevance of the topic being researched, the confidentiality of the manuscript's consideration, regardless of the race, gender, nationality, origin, religious or political views of the authors. Data, ideas, information from peer-reviewed manuscripts cannot be used for personal gain or transmitted to third parties.

The Editor-in-chief is required to refuse publication to the authors if the material reveals facts or information that violates copyright law or is plagiarized.

In order to prevent the dishonest practices of scholarly publications, the editor-in-chief should consider all claims for peer-reviewed manuscripts, published articles, and make every effort to restore justice in the event of copyright infringement.

### **Scientific research involving patients**

Patient involvement studies should be conducted in accordance with applicable law and in agreement with the ethics committee. Authors must indicate whether the 1975 Helsinki Declaration study and its 2000 revision are consistent. Patients have the right to privacy that cannot be disclosed without their consent.

## **To the authors of the scientific publication**

By submitting the manuscript to the journal, the authors guarantee the originality and reliability of the results of the scientific research. The sources used must be indicated and decorated in accordance with the requirements of the editorial board.

Plagiarism in any form, knowingly misleading information, is inadmissible, unethical and unacceptable. The dishonest practice of scientific publications also includes the submission of identical manuscripts to different publications by authors.

If a team of authors worked on the manuscript, the authors list indicates everyone who made a personal contribution to the work done.

Research authors are required to report in their manuscripts whether or not there is a conflict of interest and sources of financial support.

#### **Conflict of interests**

Authors should inform the editorial board of any potential conflict of interest that may be affected by the publication of the results contained in the manuscript. The authors are responsible for disclosing their financial and other conflicting interests when submitting the manuscript.

#### **Sources of financing**

The authors should indicate all funding sources relevant to the research, for example: "work was done with a grant (grant number)". Otherwise, it is noted that the study did not receive any financial support.

#### **License terms, copyright**

According to the current legislation of Ukraine, the authors of the article enter into a license agreement for the publication of the work, in which they indicate that they own the exclusive copyright of the submitted scientific article and grant the publisher such non-exclusive rights as publishing the article, posting it on the Internet and on the journal website, use metadata of the article, translation, distribution and introduction into various search engines, scientometric databases, transfer, storage and processing of personal data without limitation of validity. Authors also have the right to distribute the published work independently by making a bibliographic reference to the publication.

Reprinting of published articles by other legal or natural persons is possible with the permission of the editorial board and with reference to the source.

The authors of the article and the publishers of the journal are not responsible for any losses or damages related to the use of the information contained in the published materials.

### **Requirements for authors of the publication**

The editorial board only considers materials that have not been previously published in other publications. Manuscripts that have been simultaneously sent to other editions are not considered.

The article is submitted in 2 printed copies of A4 size, as well as its electronic version in Microsoft Word text editor (12 font, 1.5 interval, Times New Roman font) in email or in electronic media.

The volume of articles describing the original research should not exceed 10-12 pages, the casuistic posts should be within 4 pages, the review should be 5 pages, the literature review should be 12-16 pages.

The full name of the author, his or her exact address with the postal code, telephone number (which provides online communication with the author), email, handwritten signature are provided on a separate page. Collective signatures are required of all authors. If there are multiple authors, a digital index is placed next to each surname and its institution. If all authors work in one institution, there is no need to indicate the place of work of each author individually.

#### **Accompanying documents**

The article should have a visa of the head, an official direction and an expert opinion about the possibility of publication from the institution in which it was performed, as well as a review.

### **Required publication elements**

- UDC.
- Ukrainian and English languages are submitted:
  - initials and surnames of the author (s) (the authors' names are recommended to be translated according to the Decree of the Cabinet of Ministers of Ukraine No 55 from 27.01.2010 – [transliteration of the Ukrainian alphabet](#);
  - title of the article;
  - full name of the institution where the work was performed (without the name of its head, the name of the department, etc.);
  - address of the institution where the work was performed;
  - summary and key words;
  - ORCID for each authors of the publication, which is required to register on the site <http://orcid.org/>;
  - authors contribution (A - work concept and design; B – data collection and analysis; C – responsibility for statistical analysis; D – writing the article; E – critical review; F – final approval of the article).
- Article text with tables and pictures.

Original and problematic work should be clearly structured and divided into sections with headings:

- summary;
- introduction;
- object and methods;
- results and discursion;
- conclusions.

### **Summary**

The summary is the main source of information in domestic and foreign databases that index the journal, so it should be concise, but as informative as possible about the materials and methods of research, the content of the work and its conclusions. The summary is submitted in two languages – Ukrainian and English, its volume should be at least 1800 characters, all abbreviations should be expanded.

In addition to the content the abstract should include: the title of the article, initials and names of authors, institution, mailing address, email. After the summary, keywords in the appropriate language (3-8 words) are given.

## **Illustrative materials**

All tables are numbered in Arabic numerals and given headings for each column, with clear references to illustrative material in the text.

Photographic material should be presented separately in electronic form in TIF or JPG (quality - 12) formats. Photos must be at least 700 pixels wide. The illustrations in the files should be oriented as they should appear in the journal. Signatures to microphotographs of histological specimens should indicate the staining method and the magnification rate.

## **Requirements for the list of references**

The author is solely responsible for the accuracy of the bibliographic information in the references.

The total number of sources should not exceed 20 for original articles and 50 for literature reviews.

The bibliographic description of the literature (information) sources is made in accordance with the document "Citing Medicine", adopted by the US National Library of Medicine for MEDLINE / PubMed databases. Detailed information on the design of the List of sources used in accordance with this style can be found at: <http://www.nlm.nih.gov/citingmedicine>.

Literature lists are prepared only in alphabetical order: first in Ukrainian or Russian (Cyrillic), then in other languages (Latin). The works of domestic authors published in foreign languages are listed among the Latin publications. The works of foreign authors, published in Ukrainian or Russian, are published in Cyrillic.

References to several works by one author (self-published or co-authored) are given in chronology - from older to newer.

If articles referenced by the author have a DOI, then they should be referenced at the end of this source.

## ***Main requirements***

1. There is no comma after the last name, no space between the initials.
2. The title of the bibliographic record provides information on one, two, or three authors, and the names of these authors are not repeated in the bibliographic description.
3. In the case of more than three authors, it is possible not to list all, but through whom to indicate "et al.". If necessary, more than three authors' names can be indicated in the non-text bibliographic title.
4. Instead of the "dot and dash" sign (". -") separating the areas of the bibliographic description, it is recommended to use the "dot".
5. The title may not indicate the general designation of the material ("Text", "Electronic resource", "Maps", "Notes", etc.).
6. The physical characteristics of a document may include either its total volume (for example: 285 pages) or the page number to which the referenced object is submitted (eg: page 19).
7. The series and International Standard Number may not be disclosed (ISBN, ISMN, ISSN).

8. No spaces between year, volume (number) and pages: 2018;23:6–11.
  9. Missing spaces in page numbering: 8–10.
  10. A dot is placed at the end of the description.

References are made in the Romanesque alphabet, completely repeat the list of literature and are submitted according to the requirements of the international bibliographic standard **National Library of Medicine (NLM; <https://www.nlm.nih.gov/>)**.

When designing non-English sources, the authors and source name are translated by the system **Board of Geographic Names (BGN; <https://www.slovyk.ua/translit.php> )** or the title of the article in English, which is indicated in the publication, is given.
